Please read this form carefully and be aware that, in participating in golfing activities, you will be waiving and releasing all claims for injuries, arising from this rental and activity that you or the participant might sustain. The terms, "I," "me," and "my" also refer to parents or guardians as well as participants in the program. In renting said equipment or participating in said activities, you are agreeing as follows: The undersigned recognizes and acknowledges that golfing activities involve certain inherent risks and dangers. These risks and dangers include, but are not limited to: being struck by a golf ball or equipment, collisions, personal injury, sunstroke, near drowning or death. I acknowledge that LMLGolf, LLC, nor its members, officers, agents, employees, volunteers nor representatives are guarantors of my personal safety and that they do not have a duty to protect me from the inherent risks and dangers which I voluntarily assume while engaging in golfing activities at the Crystal Highlands Golf Course and/or using rented sport equipment, including golf carts, or use of the park property for golfing activities. I, in consideration of my rental from LMLGolf, LLC or use of the Crystal Highlands Golf Course in Festus, MO, hereby agree to waive and relinquish any and all claims I may have as a result of renting or participating in golfing activities against the LMLGolf, LLC, including its members, officers, agents, employees, volunteers, representatives, and any and all other persons and entities, of whatever nature, that might be directly or indirectly liable for any injuries that I might sustain while renting and/or operating any such golfing equipment, or participating in golfing activities. I do hereby fully release and discharge LMLGolf, LLC, and any and all other released parties, from any and all claims resulting from injuries, including death, damages, and losses sustained by anyone, and arising out of, connected with or in any way associated with my conduct and the golfing equipment rental or activities. I hereby agree to operate said rented golfing equipment, including, but not limited to golf carts or golf clubs, in a safe and courteous manner at the Crystal Highlands Golf Course at all times. I agree to be responsible for any and all damages and replacement costs for the rented golfing equipment. I have no knowledge of any physical impairment that would affect or be affected by the undersigned operating said equipment at the Crystal Highlands Golf Course. I understand that there may be further rules and regulations that must be followed. These rules and regulations may be posted or orally related to the undersigned. I agree to abide by the rules and regulations, and failure to do so may result in my being removed from the premises. I understand the nature of the golfing rental and activities for which I am registering and have read and fully understand this Waiver, Release and Hold Harmless Agreement. I further understand that any advertisements or warnings of the particular risks of this rental and activity that I subsequently receive will be incorporated by reference into and become a part of this Agreement.

Crystal Highlands Junior Golf League

About: The Crystal Highlands Junior Golf League is designed to give high school aged players a chance to compete against similar competition during the summer months. Play will occur every Wednesday in June and July, starting at 10. Players will not be required to participate each week, but doing so will improve their standings for the League Championship.

Divisions: The league will have a boys division and a girls division.

Eligibility: Players must be in high school, or entering their freshman year of high school. No high school graduates.

Format: Weeks 1-7 will be 9-Hole individual stroke play. Points will be awarded based on end results. Week 8 will be the League Championship, where the points accumulated will earn players "starting strokes" towards their stroke play 9-Hole Championship score.

Awards: $1^{st} - 3^{rd}$ Place overall awards for each division.

Play-off Procedure: Ties will not be broken between Weeks 1-7. In the event of a tie in the League Championship, play-off holes will be played until a winner is determined. If weather or other issues prevent play-off holes from being played, the winner will be determined using a scorecard play-off.

Scorecards: Players must report to the scoring table before their round to receive their scorecards, identify their golf balls, and exchange scorecards. Players must report to the scoring table after their round to sign and return scorecards. If there are any scoring/rules discrepancies, these will be resolved at this time.

Rules

- Boys will play from the white tees. Girls will play from the red tees.
- Maximum 10 stroke limit on each hole.
- The ball will be played down through the green.
- The local out of bounds rule is in effect. You may take relief laterally from where the ball came to rest out of bounds up to two club lengths in the fairway. This option comes with a 2-stroke penalty.
- Cell phones are prohibited during the round (unless in emergencies).
- A player may use a distance-measuring device to measure distance only, not wind or slope. Distances are marked on sprinkler heads throughout the fairway, to the center of the green.
- If a rules issue should arise and you are not sure how to proceed, play two balls and record both scores. We will determine the appropriate score at the scoring table after the round.
