The undersigned recognizes and acknowledges that golfing activities involve certain inherent risks and dangers. These risks and dangers include, but are not limited to: being struck by a golf ball or equipment, collisions, personal injury, sunstroke, near drowning or death. I acknowledge that LMLGolf, LLC, nor its members, officers, agents, employees, volunteers nor representatives are guarantors of my personal safety and that they do not have a duty to protect me from the inherent risks and dangers which I voluntarily assume while engaging in golfing activities at the Crystal Highlands Golf Course and/or using rented sport equipment, including golf carts, or use of the park property for golfing activities.

I, in consideration of my rental from LMLGolf, LLC or use of the Crystal Highlands Golf Course in Festus, MO, hereby agree to waive and relinquish any and all claims I may have as a result of renting or participating in golfing activities against the LMLGolf, LLC, including its members, officers, agents, employees, volunteers, representatives, and any and all other persons and entities, of whatever nature, that might be directly or indirectly liable for any injuries that I might sustain while renting and/or operating any such golfing equipment, or participating in golfing activities.

I do hereby fully release and discharge LMLGolf, LLC, and any and all other released parties, from any and all claims resulting from injuries, including death, damages, and losses sustained by anyone, and arising out of, connected with or in any way associated with my conduct and the golfing equipment rental or activities.

Hereby agree to operate said rented golfing equipment, including, but not limited to golf carts or golf clubs, in a safe and courteous manner at the Crystal Highlands Golf Course at all times. I agree to be responsible for any and all damages and replacement costs for the rented golfing equipment.

I have no knowledge of any physical impairment that would affect or be affected by the undersigned operating said equipment at the Crystal Highlands Golf Course.
